All ONGC Employees especially the offshore fraternity both Executives & staff have put in their best foot forward in these pandemic crises time since the countrywide lockdown was declared on 23<sup>rd</sup> March 2020.

The Energy Soldiers have put in relentless efforts to achieve the production & drilling targets & have kept the ONGC flag flying high. However, the latest Quarantine/isolation facility for staff being adopted by RO, Mumbai, is hurtful; the Hotel Parle International which has been panelised for staff employees for Quarantine/isolation purpose is not able to cater to our staff employees at the greatest need of the hour.

Complaints have been pouring in from offshore crew members that Hotel Parle International is not prepared to serve them in this pandemic condition. Also food and other supplements provided are of expired dates. Fruits are not of good quality, bed sheets are not cleaned properly, Housekeeping & general Hygiene is very pathetic (Actual Photographs enclosed). In these dire times, the offshore fraternity is working hard to ensure our company remains in profit, whereas, in return it seems the W.O.U. management is least bothered about their healthy and safe stay.

Sir, it is submitted that differentiating between staff and executives for Quarantine/isolation purpose is not desirable; the sentiments of staff employees have been hurt by this decision of the management & all of them are feeling deceived. Furthermore, due to poor services they fear for their health & safe stay at this Hotel.

Hence your kind authority is hereby requested to take a holistic view of the situation & not differentiate between Executive and staff for Quarantine/isolation facility at least.
