Sub: Violation of Gazette notification F.No. Z-16025/09/2011-ISH-II dated 30.06.2014.

Respected Sir,


This is in reference to the Gazette notification F.No. Z-16025/09/2011-ISH-II dated 30.06.2014, wherein S.O. 1658 (E) Clause (d) reads as follows:

“(d) the flexible pattern of work twenty one days “on-and-off” shall be adopted after the written agreements between workers’ and employers’ organizations”

At ONGC the existing duty patterns are of “2days ON- and -OFF/ 14 days ON – and -OFF/ 21 days ON – and -OFF” at various locations as adopted since inception. However, management at its will is unilaterally compelling the workmen to perform ON/OFF duty pattern upto 21 days **without any agreement with the recognized trade unions of ONGC**. This is a gross violation of the referred Gazette and Statutory regulations.






